- 2/ To accept, in cash or kind, donations, subscriptions, grants and presents and to collect dividends, interest and other income of and for the trust fund only.
- 3/ The trust is a public trust. The income and property of this Trust shall be employed towards the promotion and development of the objectives of the trust.
- 4/ To acquire movable and immovable property for the purpose of the trust and to raise and construct buildings on the immovable property thus acquired and to dispose of trust property in case the same is not required by it.
- 5/ To pay all cost, charges and expenses incidental to the Management administration and executive of trust and the powers herein contained.
- 6/ To dispose off, transfer or otherwise deal with the subject matter of the trust in such a manner as the trustees may deem fit and proper to do in carrying out the objectives of the trust.

To raise or borrow money required for the purpose of the trust with or without securities including mortgage, or charge of the trust property.

- 8/ To take over the management of any other trust or any public or private institution engaged in the activities permissible under the objectives of this trust and to do all such things which are incidental and necessary and conducive to



individual, general public institutions, Bank, Corporation, NGO's etc. and may convert the property as required by it to cash and vice-versa to effectuate the purpose of the trust.

10/ That the trust is purely a charitable and philanthropic, apolitical entity which shall work for the achievements of its objectives irrespective of colour, caste and creed and shall render its service to the mankind in its entirety.

(a) Harlep Kour W/O S. Jasbir Singh R/O Gadi Garh Jammu Teh & Distt Jammu shall be the trustee of the trust on whom shall vest the management, administration and control of the trust individually.

(b) Whosoever succeeds as a successor in interest to the trustee shall step into his shoes and in such a case as a trustee of the trust out of the committee and shall enjoy all the powers and control vested in the trustee herein.

- (d) That the trustee shall be competent to constitute a management committee for the management and execution of the aim and objects of the trust hereinafter mentioned.
- (e) The trustee may appoint an advisory board for the purpose of utilizing their services in achieving the aims and objectives of the trust.
- (f) The trustee may add and move such activities in the objectives of the trust in larger public interest as and when desired.
- (g) The funds of the trust shall be kept in a scheduled/ Nationalized Bank and shall be operated by the trustee or through any of their authorized signatories.
